FROM THE EDITOR'S DESK:

COURT CASES: DELAYING TACTICS BY THE BANK AND THE FINANCE MINISTRY ?

As you are aware, our Federation's Writ petition (originally filed in the Supreme court) is posted for hearing on 31st July 2013 in the Division Bench of the Delhi High Court. The developments in the last quarter, however, indicate that there is a deliberate attempt on the part of the Bank and the Government to prolong the legal process. On a Special Leave Petition filed by the Bank, the Supreme Court has, on 8th May 2013 agreed to consider the transfer of all pending pension related cases in Tamilnadu and Delhi (there are 8 or 9 such cases) to the same bench of the Delhi High Court where our Federation's Writ is awaiting hearing. The Supreme Court has issued notice in this regard to all the original petitioners and in the meantime stayed further proceedings in Tamilnadu Cases. There are two reasons why we consider this as a deliberate and calculated move to considerably delay the process. Neither the Bank nor the Government stated anything about such pending cases in any of their earlier written statements, counter-affidavits or replies before Supreme Court in our writ petition No184/2011. They chose to raise this matter only after nearly two years. Again, even now, neither the Bank nor the Government has stated anything about similar pending cases in Kerala, Karnataka, Andhra Pradesh, West Bengal, Rajasthan etc. So, the idea appears to be to take up such requests for transfer State by State so that the ultimate disposal of the case can be delayed by several months and possibly years.

Our Federation is examining the whole issue in consultation with our advocates. They have sought our views also in the matter. During our AGM at Kottayam on

9th JUNE 2013, we have informally conveyed the following points to our Federation General Secretary:

- a. Examine, in consultation with our senior advocates, whether we can implead ourselves in the Supreme Court and request that if at all those cases are to be clubbed, then they be transferred to the Supreme Court itself. After all, the original petition was filed by our Federation in the Supreme Court.
- b. Some of the cases sought to be transferred have been filed more than a decade back and are in various stages of hearing. One case in Chennai was in fact disposed of initially in favour of the petitioners by a single Judge in 2008 and reported to be posted on appeal for final orders by a Division Bench of the Chennai High Court. In view of the inordinate delay in the whole process and considering the age-profile of the petitioners, it is only fair that the Supreme Court stipulates a time frame for disposal of the cases or stick to the original order of "within 6 months of transfer of the papers to Delhi High Court".
- c. If transfer of cases is contemplated, all similarly placed cases from all over the country should be transferred in one go, and not in a piece-meal manner.

Pensioners' Meet and Annual General Body Meeting of SBIPAK

While delivering his welcome address Shri. Nadana Sabhapathy, Dy.General Manager and CDO, gave a brief account of the recent initiatives by our Chief General Manager to expedite settlement of the pending issues in the circle relating to the pensioners. He also commented on the cordial relationship being maintained between Circle Management and the Pensioners' Association. Dr. M.Sreenatha Sastry, Chief General Manager, Kerala inaugurated the Pensioners' meet by lighting the Nilavilkku. In his inaugural address he briefed on the business growth and branch expansion achieved by the Bank in Kerala. He also assured that issues pertaining to Pensioners will be looked into in all priority. Comrade P.P.S.Moorthy, General Secretary of the Federation of Pensioners Association delivered the key note address. While critically analysing the attitude and approach of the Govt. and more particularly of the Finance Ministry he expressed his concern and anguish that there is a deliberate attempt to prolong the court cases filed by our Associations and Federation. While offering felicitations Com. A.Jayakumar, General Secretary SBSU (KC) complimented the Pensioners' Association for becoming a fast growing organisation partly due to the massive retirements that are taking place every month. He also narrated the various welfare activities initiated by the Circle Management recently and added that approval has been obtained for opening holiday homes in three more centres namely Munnar, Kumarakom and Thekkady. Com. M.Sreenath, General Secretary, SBIOA (KC) expressed his happiness on Pensioners' Association activities and stated that more attention is now being given towards the issues pertaining to pensioners.

Shri. M J Raphael, President of our Association presided over the meeting. After the felicitations members were given the opportunity to seek clarifications from the Circle Management on pending issues, if any. Members who sought clarification include comrades P.P.Philip, V.Karunakaran. B.N.Varghese, Surendra Nath Bhas and K.Rajeevan. The meeting concluded after comrade P.U.Chellappan proposed the vote of thanks.

The post lunch session, viz.. the 12th Annual General Body Meeting of our Association began at 1.30 pm. Shri. P P S Murthy, General Secretary of the Federation and also the Chief Guest of the meeting in his special address explained in detail the genesis of our writ petition filed in Supreme Court and the various developments that followed subsequently and finally taking it to the Delhi High Court where it is awaiting its fate. In the interaction that followed after his address many of the members sought clarifications on different issues. Our General Secretary Sri. M. Sankarankutty presented the General Secretary 's report and our treasurer Sri. K. V. Kurian presented the Annual Accounts for the year ended 31.03.2013. Both were passed by the house by voice vote.

Barring the long outstanding issue of lack of adequate number of approved hospitals and diagnostic centers in our Circle, there were hardly any new subject for discussion. This position came about particularly after the present CGM took over. He is not only very cordial and positive in his approach, but proactive wherever possible. In this meeting the CGM suggested that, as the Bank has 4 Administrative Offices now at Trivandrum, Ernakulam, Trichur and Kozhikode, our Association representatives may hold monthly or bimonthly meetings with the Chief Manager(HR) of their region to sort out issues pertaining to the region. The CGM's suggestion has the advantage that if such meetings are held at A O levels, only issues not sorted out in such meetings need be brought to LHO level meetings. His suggestion was wholeheartedly welcomed by us. It was also decided that in view of the mutually acceptable level of understanding, such meetings may be held only bimonthly.
