Federation constitutes small Committee to follow up the Court cases

The Governing Body and Annual General Meeting of our Federation were held respectively on 10^{th} and 11^{th} August 2013 at Luxury Suites, Sector 18, Noida (U P). More

than 70 delegates representing all the affiliates of the Federation from all parts of the country participated in the two - day conference. The Governing Body meeting, a fore runner of the Annual General Body Meeting mainly dealt with the action taken on issues and suggestions that came up in the previous Governing Body Meeting held in Chennai on 01/10/2012. It also discussed the General Secretary's report on the developments since the last AGM held on 30/03/2012 at Ahmedabad and also the Audited Financial Statements for the year ending on 31March 2013 before giving its approval for presenting the same in the next days Annual General Meeting.

Since Shri. B.K.Ghose, the president of our Federation could not attend the meeting, the meeting was presided over by Shri. R. L. Sahu, Vice President. The presidium included S.Shri.Jairam Gupta, S.C.Rindani, M.J.Raphael (Vice Presidents) and P P S Murthy (General Secretary).

The General Secretary while discussing the court cases gave a detailed account of the developments that have taken place, ultimately resulting in transferring the petition to the Delhi High Court. He came out heavily on the attitude of the Government counsel raising the objection that in the light of some recent decisions, issues on service matters must be discussed in the High Court before they are referred to the Supreme Court. Despite the arguments put up by our Advocate that this reference to service matters can not be taken up now after a lapse of 2½ years during which no argument of this nature was put up and therefore this could not be taken up at this stage, the Judge took a decision to transfer this case to the Delhi High Court Bench with Instruction to dispose of the case within six months from the date of transfer by Supreme Court as most of the papers were perused and arguments heard.

To make matters worse, in the meantime, our Bank has filed Transfer petitions in the Supreme Court for transfer of 9 WPs pending in various High Courts to Delhi High Court for obtaining a common order and for ensuring

against conflicting judgments. If the TPs are allowed by the Supreme Court it is quite certain that Delhi High court will not be able to deliver judgment in our WP 1875/2013 within six months , since it may take even years to complete the transfer process in different High Courts. As advised by our Senior Counsel that we should intervene in these TPs and plead for not clubbing these WPs, we have arranged to file an intervening Petition in the Supreme Court.

Many of the participants, who took part in the discussions that followed after the General Secretary concluded his report, were not happy with the way things were moving. Almost all of them expressed their anguish over the unfortunate turn of events and even came out openly that there was laxity in the follow - up. It was the unanimous feeling that the transfer and clubbing of cases lying in various High Courts should be resisted as it would result in inordinate delay in getting justice.

Taking part in the deliberations Shri. L R Antony D'Couto pointed out in detail the discrepancies and deficiencies that have crept into the submissions put forward by the Bank. Quoting various instances he urged upon the Federation to have an effective follow up system especially on court cases and legal matters which was well appreciated and acknowledged by all the delegates. With all these in view, a small committee was constituted by our Federation, with three members who are experienced in the law suits and their follow up, to review the pending cases and to suggest measures to speed up the matter in consultation with our advocate who is now dealing with our case in Delhi instead of meeting him on the day the proceedings are posted to. We are happy that Shri Antony D'Couto has been nominated to the committee. As you are aware our case now is being handled by the retired Advocate General of Chattisgarh State.

The Annual General Body Meeting held on 11th August covered issues including co ordination with other organisations. Majority of the delegates who participated in the discussions favoured coordination with serving organisations in the Bank. Resolutions were moved and adopted thereafter. The meeting concluded after submission of reports by affiliates.

RESOLUTIONS ADOPTED BY THE ANNUAL GENERAL BODY AT ITS MEETING HELD ON 11.08.2013 AT NEW DELHI

The Annual General Body Meeting of our Federation resolved to appeal to the Corporate Centre of our Bank to consider the following requests favourably.

i) To arrange for extension of the benefit of Updation of pension on every revision of salary on the same basis as is done by the Central Government to its employees.

- **ii)** To arrange for the revision of the family pension at 30% of pay to all.
- **iii)** To arrange for payment of improved pension and family pension to all those aged 80 and above on the same basis as paid by the Government.
- **iv)** Pending revision of family pension at 30% of pay to all, to arrange for the revision of family pension of pensioners retired between 01.11.1987 and 01.11.1992 / 02.07.1993 on the basis of revision of family pension made in January, 2008 with suitable increase in minimum family pension now being paid on the Fourth Bipartite Pay scales.
- **v)** To arrange for applying the same formula adopted under the Industry Level Pension Scheme for the commutation under our Pension Scheme.
- **vi)** To arrange for payment of enhanced gratuity up to Rs.10 lacs to all those who retired from 01.01.2006 to 23.05.2010 by sustained follow up with the Government.
- **vii)** To arrange for revising minimum pension corresponding to the revision made on the basis of industry level pension settlement.
- viii) To request our Bank to make additional contribution, if necessary to the Corpus of REMBS, for modifying this Scheme by
- **(a)** Enlarging the eligible diseases to cover all ailments in particular Gynaecologic Diseases, hysterectomy, asthma, ENT, Neurological disorders, Removal of Kidney Stones and bronchial disorders requiring hospitalization.
- **(b)** Making the scheme eligible for meeting the medical expenses incurred on domiciliary/ hospitalization treatment under alternative system of medicines like ayurveda, sidha, homeopathy, acupuncture, acupressure and unani.
- **(c)** Extending the coverage of the recently improved Medical Benefit Scheme to all those who retired before attaining the age of 60 years, including the VRS and Exit option retirees with a stipulation to avail of the benefits on attaining the age of 60 years.
- **(d)** Extending the coverage of 20 ailments to the members of Scheme I and II with domiciliary facility.
- **(e)** Making all members of REMBS I eligible for admission to improved REMBS II
- **(f)** Extending the benefits of the REMB Scheme to disabled children, widowed daughters and dependent parents
- **(g)** Providing for hospitalization as well as domiciliary treatment for the treatment of all terminal illnesses
- **(h)** Making the Scheme eligible for admission of the family pensioners by accepting applications from them, after the death of their spouses, while in service or after retirement
- (i) To consider making improvements in the REMBS for providing the maximum cover of Rs 20 lacs to all cadres of

pensioners willing to pay the contribution and increasing the domiciliary facility from 10% to 20%

- **j)** To delegate the authority for approving the hospitals and dispensaries, as per the norms stipulated by the Bank to LHOs with adequate mechanism for monitoring the proper functioning of the dispensaries and for ensuring availability of funds by getting timely and adequate allocation of funds necessary for prompt payment of bills under REMBS
- **(k)** To arrange for publication in vernacular languages the extension of the family pension by our Bank to the spouses of the deceased ex-servicemen employees in addition to the family pension from the Government and also the payment of compensation to the spouses of the employees of our Bank, who died while in service
- **ix)** To provide one more opportunity to the VRS /Exit option Retirees, who have not paid the arrears of subscription to MWF up to 60 years of age within six months from the date of retirement and make them eligible for availing of the benefits of the Scheme on attaining the age of 60 years
- **x)** To recognize the Federation and Associations of Pensioners and provide office accommodation and other facilities to our Federation and its affiliates in all Circles to enable them to provide the various services required by past employees of our Bank
- **xi)** To restore the concession of the additional interest at 0.50% p.a., as against 0.25% as of now on the deposits of Senior Citizens
- **xii)** To provide the overdraft facility exceeding Rs.3 lacs granted to pensioners of our Bank against their deposits at the same rate charged for overdrafts less than Rs.3 lacs
- **xiii)** To arrange for providing the concessionary facilities including interest on secured advances like gold loan extended to the serving staff of our Bank, to pensioners and family pensioners of the Bank by making suitable changes in its Core Banking software packages.
- **xiv)** To arrange for providing locker facilities to Pensioners and family pensioners of our Bank on the same terms without any limit on the number of operations as provided to the serving staff
- **xv)** To arrange to extend the facility of interest free festival advance provided to the serving employees to the pensioners of our Bank also to enable them to meet the expenses for celebrating the festivals.
- **xvi)** To provide the same concessionary rate of interest at 8.00% p.a. instead of the rate applicable to the public, on the educational loans granted to the children of the employees, while in service, even after retirement.
- xvii) To arrange for establishing dispensaries at all eligible centres and District Head Quarters with adequate stock of

standard medicines, for meeting the requirements for this purpose and to adopt a uniform procedure by the appointment of a committee consisting of the Bank's Chief Medical Officer (Not Civil Surgeon) and one or two Officials of the Bank for appointment of Doctors at the dispensaries. **xviii)** To arrange for the review of REMBS of e-State Bank of Indore and provide for the same

medical facilities provided by State Bank of India to the pensioners of e-SBS and e-State Bank of Indore.

- **xix)** To arrange for providing one more option to the VRS Retirees of e-SBS and e.SB of Indore for joining the Pension Scheme.
- **xx)** To arrange for the merger of data by CSPPC relating to the pensioners of e-SBS and e-SB of Indore after due verification of the accuracy of the data.

The Annual General Body of our Federation resolved to seek co-operation and support from The All India State Bank of India Staff Federation and All India State Bank Officers Federation.

COURT CASES PENDING DELHI HIGH COURT W.P.(C) 1931/2002

The case was last heard on 22-08-2013. In order to evaluate the data furnished by the Bank emanating from its order dated 21-02-2013 the court has called for further particulars as to how the Pension Corpus fund has increased. While granting the Bank six weeks to do so and posting the case to 10-10-2013 the Court made it clear that it will not accept any delay beyond the period granted. It is expected that the hearing will conclude at an early date .We hope that the judgement will bring some relief to the suffering pensioners.

DELHI HIGH COURT W.P.(C) 1875/2013

(Our W.P.(c) 184/2011 transferred from the Supreme Court)

It may be recalled that our W.P.(c) 184/2011 was transferred to the Delhi High Court by Supreme Court order dated 27/02/2013 with a direction for its early disposal at any time within the outer limit of six months from the date of receipt of the records. The case was first listed in the Delhi High Court on 02-04-2013. The case which was last posted for 31/07/2013 was reposted to 19/11/2013 for issuing fresh notice to the Reserve Bank of India.

CALCUTTA HIGH COURT W.P.NO.1317/2009

On 13^{th} September 2012the Calcutta High Court has directed the State Bank of India to calculate the pension benefits of the petitioner (Shri Salil Kumar Ghosh who retired on 30-11-2001) on the basis of the pay received by him under the 7^{th} Bipartite settlement. The Court held that AT THE TIME OF RETIREMENT he was receiving the revised pay under the 7^{th} Bipartite settlement. It is reported the Bank will appeal.

TRANSFER PETITIONS 750-758 IN THE SUPREME COURT OF INDIA

It may be recalled that on 16/10/2008 the Madras High Court had directed the Government of India to consider and approve the Bank's recommendations dated 19/04/2006 for re-fixing the pension of the 7th Bipartite retirees. These cases were being heard by the Madras High Court on appeal by the Bank and were posted for orders in February 2013. After seeking adjournment the Bank filed a Transfer petition seeking transfer of this case and some other related cases to be heard along with our Case No.1875/2013 in the Delhi High Court. Simultaneously the Supreme Court also stayed the proceedings of these cases in the Madras High Court. The case is now posted to 18/10/2013.

KERALA HIGH COURT W.A.NO.1903/2010 SBI VS T.R.VIJAYAN AND OTHERS

Shri T R Vijayan and 19 others who were 7^{th} Bipartite retirees had filed a W.P.(c) No.27929/2003 seeking revision of their pension fixed on PRE-REVISED SCALES. The petitioners had received a partial judgement in their favour on the basis of their petition to the court. It is against this judgement dated 14/09/2010 that the Bank had filed an appeal dated 23/10/2010. This appeal has not been listed for hearing as yet.

SUPREME COURT OF INDIA SC 639/2013. STATE OF JHARKHAND AND OTHERS VS J.K.SRIVASTAVA AND OTHERS

In its judgement dated 14-08-2013 the Supreme Court has reiterated, among other things, that pension is in the nature of property. It is stated by virtue of Article 300 A of the constitution that no person can be deprived of his property except by authority of Law. It therefore has held that pension can be with held only by due process of law and NOT by Executive Orders which cannot be termed as Law. The spirit of this judgement has a bearing on some of our pension issues which have been placed before the Courts.

Attention 5th & 6th Bipartite Pay Scale Retirees & Improvement in SBIRE Medical Benefit Scheme - II

Federation has advised that Central Board of Bank has passed a resolution revising pension ceiling of 5^{th} & 6^{th} Bipartite retirees and is expected to put up proposal to the Govt for its approval.

Also, a proposal for some improvements in SBIREMBS-II is underway. The details are given here:-

Revision of Pension on 5th and 6th Bipartite Pay Scales

It is advised by our Federation that a resolution has been passed by the Central Board of our Bank for revising the pension ceiling of Rs.2,400/- to Rs.3,775/- on 5th Bipartite Pay Scales and for the payment of pension on 6th Bipartite Pay Scales for those retired from 01.11.1992 (Award Staff)/ 01/07/1993 (Officers) at 50% up to Rs.8,500/- and at 40% for pay above Rs.8,500/- w.e.f. 01-03-1999. Our Bank is expected to put up proposal to the Government as per this resolution for its approval. This revision is expected to be made after the approval of the Government.

Improvement in SBIRE Medical Benefit Scheme II

It is also advised by the Federation that a proposal is under consideration for increasing the coverage under REMBS- II from Rs.7 lacs to Rs.10 lacs for all cadres up to AGM with suitable increase for scales above AGM on payment of additional contribution, for including some more ailments particularly for gynecological disorders and for making the above Scheme eligible for admission to the spouses of the diseased employees, while in service and those retired employees who passed away before the expiry of three months from the date of receipt of pension.
