As all are aware, the previous structured meeting by Corporate Management was held on 25th November 2019 at Indore. Thereafter no meeting could be held due to the alarming situation prevailed in our country with the spread of Covid 19 and the restrictions imposed by the Governments in undertaking travel, holding meetings etc.

We are indeed happy that the meeting which was held after almost two years gap could definitely rejuvenate the bilateral mechanism for resolution of issues pertaining to the elders and seniors who in their heydays served the Bank with utmost dedication and commitment. The meeting commenced at 3.30pm with the welcome address by Shri Arun Kumar Sahu, DGM (P&PMD) Thereafter, the participants paid homage to hundreds of our departed pensioners and family pensioners, who left for their heavenly abode mostly due to the Covid 19 pandemic. The participants observed 2 minutes silence in respect of the noble souls.

The DMD & CDO, while extending warm welcome to the Presidents. General Secretaries and other office bearers of the Federation and its affiliates, expressed his happiness to see the large participation of representatives from all over the Country, despite the COVID restrictions and controls imposed at various levels. He further said that the representatives looked more vibrant even in the post-Covid grim-situation and the age looked no bar on them to partake in the meeting. The proceedings went on in a cordial atmosphere with exchange of views on the scheduled agenda. The DMD & CDO inaugurated the LC Submission Awareness Video prepared by the P&PM Department. The officials from the Corporate Center also made a power point presentation on the initiatives of the department for the benefit of pensioners.

Thereafter, the following agenda items were taken up by the President Shri G K Gandhi in detail and supplemented by the General Secretary Shri A.Ramesh Babu.

- Improvements in Pension, Updation of Pension, 100% DAto pre-2002 retirees.
- Payment of pension on PQP & FPA components to 7th bipartite retirees
- Review of fitment to the 8th bipartite retirees
- REMBS Easing out processes for Reimbursement of Quarantine Treatment cost
- Release of stagnation increments of 10th and 11th bipartite retirees
- Providing office space for Pensioners Associations in each Circle
- REMBS Associate Banks
- Individual House Loans (IHL) Streamlining the procedures for Waiver on death of pensioners

- Immediate stoppage of recovery of instalment on IHL on the death of pensioner
- Ease of doing in sanction of Family Pension, life Certificate
- UR WORLD FACILITY Extension to Policy 'A' holders; Reach out to Pensioners in Rural areas.
- Purification of data to avoid payment of premiums for Policy 'A' holders, in case of death of both pensioner and family pensioner.
- Review of opening of Dispensaries at new centers
- Delay and disallowing in reimbursement of Medical Expenses under Policy 'A' &'B'
- Life Certificates up loading issues

All the items slated above, were discussed in detail. The DMD & CDO mentioned that Bank has been empathetic towards pension related issues and had appraised the DFS, Government of India in the matter for a resolution. The President and General Secretary profusely thanked the Chairman and everyone in the Management for disbursing family pension arrears to nearly 45,000 family pensioners on the eve of Diwali day and also releasing circular and requested to ensure that remaining family pensioners also get the much awaited increase in family pension soon. Then the leaders from the federation, elaborately brought out the problems faced by pensioners across the Country on each of the above items.



The DMD & CDO participating in the deliberations on all our issues directed the P& PM Department to positively resolve the issues and also suggested Federation to send a detailed note to his office immediately and assured to address the issues, also assured to

have a Small Committee Meeting at the Corporate Center to resolve the issues. The Vice President of Anand Rathi Insurance Brokers Limited taking the suggestions of the Federation, assured to enlarge the scope of the insurance coverage in consultation with the SBI General Insurance Company, in the ensuing renewal of Mediclaim policy for the year 2022-23.



The Corporate Management was also requested to discuss with the SBI General Insurance Company, to keep the premium at the same level. It was agreed to have an exclusive meeting with Insurance Brokers/ TPAs at Circle levels, to discuss on day- to-day issues. It was suggested by the Federation that for the treatment of Cancer medicines are available and also a clause is to be included for protection of minimum eligible amount of other expenses according to the base policy of the pensioner and also make it user friendly.

Thereafter, felicitations were extended by DMD & CDO to all the Federation leaders. Reciprocating the gesture of the Management, Shri G.K. Gandhi, President, Shri A. Ramesh Babu, General Secretary and other leaders of the Federation honored the Management Executives.

The meeting was also attended by Shri Ranjan Gupta, CGM(HR), Shri A.Thorat, CGM(Law), Shri S.T.Lama, GM (PMPD), Shri Arun Kumar Sahu, DGM (PPG),) Shri K.K.Singh, AGM (P&PMD) Shri Sandipta Kumar Nayak, AGM (P&PMD). Shri Kishore Kumar Singh, AGM-(PPG), Special Invitees for the meeting included Shri Amit Jhingran, CGM (Hyderabad Circle), Shri Debashish Bhattacharjee, DGM&CDO, Hyderabad Circle and Shri Ramnarayana Boga, GM, SBIRB.

Shri Debashish Bhattacharya proposed a Vote of Thanks and the meeting concluded at 6 pm.



Our President Shri K.Rajeevan and General Secretary Shri A Jayakumar attended the meeting on behalf of Kerala affiliate and actively participated in the discussion on agenda items and highlighted some of the long pending issues namely, nomination facility for LTA,, delay in settlement of HTL outstandings of deceased pensioners and the harassment suffered by poor family pensioners from the Recovery Agents arranged by RACPC, pending mediclaim bills with the previous insurance companies, IFFCO TOKIO and UNITED INDIA INSURANCE CO. delay in sanction of family pension due to delay in reporting the death of the pensioner by the pension paying branches for which DMD left instructions to the DGM PPG to look into the issues for urgent resolution.

Appointment of Pharmacists in Bank's Dispensaries

Members are aware that our Association has been repeatedly requesting the Bank for appointment of Pharmacists in all the dispensaries. We are happy that Bank has considered positively and acceded to our requests. Accordingly six pharmacists have been selected for appointment in all the dispensaries, wherever permanent Doctors are posted, and we understand that all of them will be reporting shortly. Federation held its Governing Body and General Body Meetings on 10th and 11th December at SBIL&D, Gachibowli



We are indeed happy to report that after a gap of almost two years the Governing Body and Annual General Body meetings of our Federation were held on 10th and 11th December respectively at State Bank of India Institute for Learning and Development, Gachibowli Hyderabad. The meetings which had to be deferred during the previous two years due to the Corona alarming situation in the country were made possible with the consent and active participation of the leaders from all affiliates across the country.

The GB meeting commenced at 3 pm and was inaugurated by Smt Rajni Bala Mazumdar, Assistant General Manager & Director, SBILD She was honored by the President and General Secretary with bouquet, shawl and gift hamper.

She began her inaugural address saying about the inadequacies in the Centre to provide facilities for such a gathering of distinguished elders and shared that with the admirable support of Federation General Secretary and others who are on locale, she could arrange for comfortable stay for all and also requested to bear with her duly considering the limitations. She appealed to all pensioner representatives to demat the physical form of shares and open Demat accounts for better safety of the shares. She wished that the deliberations in the two days' meeting would pave way for more benefits to both the present and future retirees of our Bank.

Shri G K Gandhi President expressed our deep felt thanks to Smt Raini Bala Mazumdar for having inaugurated the meeting with her inspiring speech. President after declaring the meeting in order, made sad remembrances of late Santha Raju Sr. Vice President and G. Sukumar GB Member and General Secretary of Karnataka affiliate who left for their heavenly abode due to Corona pandemic and requested all to observe two minutes silence. He then began his brief opening remarks touching upon major issues confronted by Bank Pensioners in general and SBI Pensioners in particular including the latest on developments in pension Updation issue. He also shared with the participants about the IBA Chairman's address in the recently held meeting with retirees of e-SBBJ and expressed his expectation of conclusion of Updation of Pension issue by March 2022. He further touched upon the ensuing Triennial election of Office bearers of the Federation and hoped to hold it in the next AGM hopefully convened in July 2022. The agenda for the Governing Body Meeting was taken up thereafter by the General Secretary.

While reporting the latest on our WP 1875/2013 in Delhi HC, General Secretary reported that Federation's application on 28th October 2021 for early hearing, which came up for hearing on 12th November 2021 was rejected by the HC with a suggestion to apply for early haring in February 2022. He further added that in response to the strong resentment expressed by many affiliates, the Core Committee which met on 31st October has taken a decision to change the present Senior Counsel and already requested the AOR to furnish names of few Senior Counsels of good standing in Delhi HC so as to replace the present Senior Counsel.

The meeting thereafter discussed on the issues relating to delay in payment of arrears in respect of revised family pension, non sanctioning of stagnation increments as per 10th and 11th BPS, delay in payment of arrears on account of 11th BPS to those who retired after 1/11/2017 etc.

The meeting also co-opted Shri H. Ganapathy as Senior Vice President of the Federation in place of late Santha Raju, Sr. Vice President which was unanimously approved.



The meeting discussed about the ensuing election of office bearers of the Federation for the next triennial term, since the term of the present committee is expiring tin February 2022. It was decided to hold the next AGM in June/July 2022 and to hold the elections. The GB then decided to request the next days AGM to approve extension of the term of the present committee till next AGM. The meeting concluded at 6 pm

Annual General Meeting on 11th December 2021 at SBIL&D, Gachibowli

presidium members who included Senior Vice Presidents, General Secretary and Secretary.

After the condolences and paying respectful homage to those who left for their heavenly abode since our last AGM held at Mysuru, in January 2020, the agenda items were taken up in order, The meeting, ratified the decisions taken in the GB meeting held on the previous day. The minutes of the previous meeting was read out by the General Secretary. Thereafter, General Secretary submitted his report followed by presentation of financials by M S Mohan Rao, Treasurer including the approval for statement of accounts for the years 2019-20 and 2020-21.



The decision taken to extend the term of the Federation by six more months and co-option of Shri H. Ganapathy as Senior Vice President were endorsed by the members present. Shri Shri Deepak Basu, Secretary of the Federation explained in detail on modalities of REMBS and Insurance Scheme, Members actively participated in the deliberations include S/s Upendra Kumar Dash, H.Ganapathy, K.Rajeevan, P.B.Khanna, Atul Swaroop, S.K.Sharma, T.R.Gupta, Dinesh Chandra, R.P.Saxena, Dispak Basu and Ganesh Misra.



Comrades, the two days' meeting of our Federation ended up astoundingly that it could rejuvenate the Federation after the slow pace in activity due to the Covid restrictions and controls for almost a year and a half. We are confident that it will attain bigger heights in the days to come with its refurbished vigor and vitality.

Shri G K Gandhi, our President and Shri A.Ramesh Babu General Secretary deserve all appreciation for making the two day's meeting a memorable one in all aspects. The meeting was concluded with vote of thanks by Shri Ganesh Misra, President, SBIPABhubaneswar.





Executive Committee of SBIPA Kerala decided to hold the Annual General Meeting in May 2022 and District Annual General Meetings before 31-03-2022

The Quarterly Executive Committee meeting of SBIPA Kerala was held online in Google platform on 21st December 2021.

The meeting started at 10 am under the president ship of K Rajeevan, State President, with silent prayer, followed by paying homage to 25 members (18 life members and 7 associate members) who passed away since last meeting, observing a minute's silence.

Shri Rajeevan began his presidential address expressing his utmost appreciation for all the District Secretaries for conducting district level Executive Committee meetings and for submitting the reports well before the day's State EC Meeting. He further complimented some of the District Leaders who held General Body Meetings also during the period.

He also briefed on the deliberations that took place during the corporate centre structured meeting held on 9th December at Hyderabad and expressed happiness in the response from top management on various issues raised by the federation. The president also called upon all EC members to emphasize the importance of having the insurance cover (policy A and/or policy) during interactions with members. Shri K.S Jayaram, treasurer, thereafter, presented the position of accounts as on 30.11.2021 which was approved unanimously.

General secretary presented the minutes of the last EC meeting which was approved with few minor corrections. He then presented his report on the activities during the report period which covered delay in payment of arrears on account of revision of family pension to majority of the eligible family pensioners, delay in payment of arrears on revised gratuity, delay in approval of 8th and 9th stagnation increments as per 10th and 11th BPS. He briefed on the discussions that took place during the corporate centre structured meeting, Federation GB and AGM held respectively on 9th 10th and 11th December.

Touching upon on organisational matters he mentioned about the forthcoming Annual General Meeting of the association proposed to be held at Thrissur on 14th may 2022 and the need to elect new district committees before it.

Shri TT Balakrishnan, DGS, Thrissur briefed on the preparations for holding the proposed AGM and confirmed arrangements in respect of Venue of the meeting and stay and accommodation for participants. He further added that the district committee is fully geared up to make it a grand occasion, bearing in mind the Covid restrictions.

Reporting by Vice Presidents, Lady Member, Deputy General Secretaries, Asst. General Secretaries and all District Secretaries followed thereafter.

The meeting deliberated on issues pertaining to delay in opening of Bank's Dispensaries at Kasaragod, Wayanad, Malappuram and Thiruvalla for which approval was received in the month of July and decided to bring it before the Chief General Manager. The other issues deliberated in the meeting included delay in sanction of 8th and 9th stagnation increments to retirees who are the beneficiaries of 10th and 11th BPS.

Summing up the deliberations President and General Secretary assured to take up all the issues raised by the members with the Circle Management immediately so as to resolve it without delay. It was also decided to suggest to all district units to complete the election exercise latest by 15th March.

The meeting concluded at 5.45 pm with a vote of thanks proposed by Mr Mathew Adackamundackal, DGS Kottayam.

Structured Meeting by LHO, Thiruvananthapuram with SBIPA Kerala

The half yearly structured meeting by the Circle Management with Pensioners' Association Kerala was held on 19th November in the Conference room of LHO Thiruvananthapuram.

Those who are stationed at Thiruvananthapuram attended the meeting at LHO and others participated through VC from different AO locations across the state.

The meeting which commenced at 11am was presided over by Shri K. Shreekant, Chief General Manager. The participants at LHO included Shri V Seetharaman, GM Network 1, Smt. Vandana Mehrotra, GM Network 3, S/Shri Shivaprakash, DGM & CDO, Vinod Kasturi, AGM (HR), Smt. Jennifer Patricia Luiz, AGM(PPG) and Smt. Sreedevi G.

After the welcome address by CDO, Chief General Manager delivered the Presidential address highlighting the business priorities of the Circle in particular and the Bank in general.

He appreciated the support of Pensioners' Association and also acknowledged the services rendered by the seniors and elders while in service and expressed his gratitude.

Shri K Rajeevan, President who attended meeting through VC at Calicut AO, in his opening remarks explained in detail the activities and prominent role played by the Association for the welfare of its members and gratefully remembered the remarkable support extended to Pensioners' Association by the previous Chief General Managers who not only gave priority in resolving the issues of pensioners and retirees but also provided the Association's Administrative Office in Thiruvananthapuram and office spaces at AOs. He added that the system of holding quarterly structured meetings at all AOs was introduced by one of the previous CGMs, which is very successfully going on resulting in substantial reduction in issues that are carried over to LHO structured meetings. He also highlighted the issues pertaining to payment of Arrears in

respect of 11th BPS revised Salary, PF, Gratuity, and also 8th and 9th Stagnation Increments introduced as per 10th and 11th BPS.

Shri Jayakumar, General Secretary in his opening remarks supplemented other issues including erroneous calculation in Family Pension, delay in approval and sanction of 8th and 9th stagnation increments, Pension Revision etc.

Agenda items were thereafter taken up. We are indeed so happy that CGM responded very positively to our requirements and issued instructions to all concerned for immediate redressal of all the issues that were raised in the meeting.

The decision has been taken on account of the restrictions reimposed by Union Government due to the countrywide increase in instances of OMICRON. Members may please note. DGS Shri Joseph Palackal began his address with reference on Shri Prem G. Nath, AGS who is undergoing treatment and how much his absence in the day's meeting is felt by all. He also shared about the improving health condition of Shri Prem He requested the members to have a self evaluation of their contribution to the Association after getting elected as EC members. He thanked all the members for their unstinted support for bringing up the Association to its present level. He expressed happiness in respect of functioning of Ekm Unit by adhering to all the instructions issued by parent union from time to time. He reiterated that this was only possible due to the collective effort by each one and requested all to continue with the same spirit. He further explained in detail about the Bank's Medical Insurance policies of both Policy A (SBI Health Care) and Policy B (SBI Health Assist). He also reiterated that such low premium insurance, that also without medical checkup, is not offered by any other insurance company and requested all those who are yet to join the scheme to join without any lapse of time. Regarding pension revision he mentioned that the Federation is making all efforts to achieve revision of our pension whichn is under active consideration of our Government. He shared the happiness expressed by the family pensioners for achieving the revision in family pension. He informed that around 700 family pensioners are yet to receive the revision and the work is in progress. The mistakes and differences of family pension calculation will be rectified in due course. Structured meeting at AO which was scheduled on 14/12/21 was postponed due to the preoccupation of DGM and rescheduled it on 22/12/21. He also mentioned about the Structured Meeting by Corporate centre with the Federation of Pensioners Associations held on 9/12/21 at Hyderabad presided over by DMD CDO wherein many of the burning issues of SBI pensioners were discussed and positively responded by the management. He also mentioned about the All India General Body meeting held at Hyderabad on 10th and 11th December 2021, DGS mentioned about our triennial election process to be held in March 22 the preparation for which has to be started at the

earliest. An EC meeting will be conducted in the third week of Jan 22 to finalise the date of election and other formalities. He also suggested for reconstituting the areas on the basis of membership strength for making the organisational functioning more effective... DGS informed that a temporary doctor has been appointed and has reported for duty on 15/12/21. He reminded that the pending insurance claims for the period 16/1/2021 to 15/01/22, if any, to be submitted before 15/01/22. He concluded his address wishing DGS Happy Christmas and Happy New Year to all participants.

The interactive session that followed thereafter was so active with many members seeking clarifications on Insurance schemes, pending mediclaim bills etc. DGS Shri Joseph Palackal replied to all the querries asked by th participants.

The meeting concluded at 12.30 p.m. with the vote of thanks by Asst. Treasurer Smt. Beena K Ravi.

"Retired Employees can form a Union" Justice S Vaidyanathan, Madras HC

"The Madras High Court has made it clear that Law does not state that only serving employees of an organisation can form unions under the Trade Union Act, as even retired employees can form a separate union to espouse their grievances relating to terminal benefits and register it.

Justice S Vaidyanathan made the observation while allowing a plea moved by Karur Vaisya Bank Retirees Association challenging the order of the Labour department denying registration to their Association on the ground that the members of the Association are not in service.

"India is a democratic country, where there is no restrictions for citizens to express their grievances to Government by means of Ahimsa and as such, preventing one sect of persons, namely, retired employees to form a trade union to espouse the cause to the Government cannot be permitted at any cost, by giving a different interpretation to the provisions of law ", the judge said.

To put it precisely, even if seven employees were not on the rolls, they are entitled to form an association that has to be registered under the Trade Union Act and the same cannot be refused to be registered on this core, the Judge said.

Though the existing union with permanent employees can espouse the cause of retired employees for others, who were not in employment on the ground of community of interest, consequent to the absence of such interest in the present days, there is nothing wrong in permitting the retired employees to have their own Association under the Act, as unions, having permanent employees on the rolls, are withering away and shirking from their moral responsibilities to espouse the cause of employees who ceased to be on the rolls, said Justice Vaidyanathan.
